

**Why did Milliken decide to enter the outdoor specialty market?**

The outdoor specialty market is a natural extension of the indoor residential market and many of our existing customers have expressed the need for more options in the outdoor space. This expansion allows us to leverage our ability to scale, our chemical and textile expertise as well as bring fresh fabric solutions to the outdoor market.

**What makes these performance outdoor fabrics?**

Milliken Outdoor Fabrics are purposefully designed with durability and cleanability in mind. The fabrics are made from 100% solution-dyed acrylic fibers that are inherently mold and mildew resistant. The fabrics have a non-PFAS (per- and polyfluoroalkyl substances) performance finish that make them easier to clean and water-resistant. Solution-dyed fabrics have been used in the outdoor market for 50+ years and are known to perform well against unique outdoor conditions such as UV rays. **Do these fabrics have any environmental concerns?**

No. As a values-based company focused on sustainability efforts, our fabrics use a non-PFAS finish (per- and polyfluoroalkyl substances). The fabrics are certified product Class II according to STANDARD 100 by OEKO-TEX® and is UL GREENGUARD® Gold Certified.

**Why is your finish non-PFAS?**

As materials science experts, Milliken has always tried to maintain a product portfolio that is responsive to where the market is going. With recent EPA regulation announcements, we believe the market for products made with PFAS chemistries is shifting, and as a result, we have proactively eliminated PFAS-containing materials from our textiles. **Does Milliken's Non-PFAS finish affect performance or cleanability?**

Milliken fabrics with non-PFAS finishes still have excellent water-based stain repellency but as with all non-PFAS finishes, oil-based stains will be absorbed. However, oil-based stains can be cleaned out of Milliken fabrics with proper cleaning techniques. These finishes do not affect the look or feel of the fabrics.

**Are there any concerns with these fabrics regarding California Proposition 65 and REACH?**

These laws are constantly being updated; therefore, up to date documentation is available upon request. Currently our products do not require labeling per California Proposition 65.

**Where are the fabrics manufactured?**

Milliken Outdoor Fabrics are manufactured in Asia and North America.

**Does Milliken offer custom designs?**

Yes, the Milliken Outdoor Fabrics currently have two collections, New Vistas and Outer Realm. We will be continually introducing new designs and patterns. If you have a custom need, let's work together! There will be a longer lead time if your desired colors are outside of our current color palette.

**What are the lead times, and where will the fabrics ship from?**

The stock patterns in the South Carolina warehouse will ship out in 1-3 business days. If it is an out-of-stock fabric or a custom request, there will be a longer lead time. Please reach out to your account manager for lead times.

**What are the fabric roll specifications?**

The usable fabric width is 54", the standard roll size is 55 yards long and it comes on 2" cores.

**Is there a minimum order size?**

The minimum order is one roll.

**What is the warranty on Milliken Outdoor Fabrics?**
